WBUK will return your funds to the UK daily; ii) deposits to and withdrawals from your account; iii) converting currency; iv) passing orders on to WBAU for execution; v) ensuring the quality of the execution of orders (“Best Execution”); vi) ensuring that WBAU has appropriate safeguards in place to protect your assets.

WBAU will perform execution, settlement and custody services for clients of WBUK. WBAU will be responsible for: i) execution and settlement of your trades; ii) safe custody of your assets; iii) safe custody of your money (to the extent this is not held by WBUK); iv) collecting fees and commissions on behalf of WBUK and other third parties.

The regulations surrounding the safeguarding of assets may differ between Australia and the UK. While WBUK has assessed that there are appropriate safeguards in place and assets are effectively protected under the rules set out in Part 7.8 of the Corporations Act 2001, these may differ from regulations in the UK.

In particular, you may not have access to the UK Financial Services Compensation Scheme for activities performed by WBAU, but may instead have a claim under insurance held by WBAU in accordance with s912B of the Corporations Act for this purpose.
